

## International Credit Union Day Social Media Trivia Official Contest Rules

**CONTEST PERIOD:** Contest begins on October 15, 2020 at 12:00am PDT and ends October 16, 2020 at 12:00am PDT.

**ELIGIBILITY:** No purchase is necessary to win. Cutting Edge Federal Credit Union (CEFCU, or henceforth the "Credit Union") Board of Directors, Supervisory Committee Members, and Employees and their immediate family members are not eligible to win. Individuals are eligible to win one (1) prize per contest.

TO ENTER: Any entry may be submitted by commenting on the International Credit Union Day Facebook posts located on the official CEFCU Facebook page, located at <a href="https://www.facebook.com/cuttingedgefcu">www.facebook.com/cuttingedgefcu</a>. The first to comment with the correct answer to the trivia question will be selected as the one winner per trivia question, for a total of five winners for this contest. Entry is only valid on October 15, 2020. To enter without purchase or obligation: print your name, address, city, state, zip code, and phone number on a 3"x5" card and the words "Cutting Edge Federal Credit ICU Day Contest."

**PRIZE INFORMATION:** Five (5) winners will be selected to win among all qualified entries submitted during the contest period. Winner selection will be determined within one (1) business day at the end of the contest period. Individuals need not be present to win. The odds of winning Prize depend on the total number of qualified entries submitted. Cutting Edge Federal Credit Union will notify the prizewinner

personally by either telephone, email, or Facebook Messenger using the contact information supplied. It shall be the responsibility of entrants to provide contact information within their Facebook Account in order to be eligible to collect the prize. Entrants may be asked to provide proof of eligibility to enter.

No transfer or substitution of prizes is permitted. All federal, state, and local taxes, if any, are the sole responsibility of the winner. Prize may be subject to Internal Revenue Service Form 1099 reporting. Winner must claim his or her prize within seven (7) business days of being notified by Cutting Edge Federal Credit Union or entrant will be deemed to have forfeited his/her prize.
