



## ***HELOC Promotion Vacuum Drawing Official Contest Rules***

**PROMOTION PERIOD:** Promotion begins on April 1, 2021 at 12:00am PDT and ends either on June 30, 2021 at 5:00pm PDT, OR when the credit union reaches its promotional financial campaign goal; whichever occurs first. All Cutting Edge Federal Credit Union loan programs and promotions and conditions are subject to change at any time.

**ELIGIBILITY:** No purchase is necessary to win. Cutting Edge Federal Credit Union (CEFCU, or henceforth the "Credit Union") Board of Directors, Supervisory Committee Members, and Employees and their immediate family members are not eligible to win.

**TO ENTER:** Members who open a Home Equity Line of Credit (henceforth "HELOC") during the Promotion Period will be automatically entered.

To enter without purchase or obligation: print your name, address, city, state, zip code, and phone number on a 3"x5" card and the words "Cutting Edge Federal Credit Union Shark Rocket Lightweight Cordless Stick Vacuum Drawing."

Entries must be postmarked no later than June 15, 2020 to be entered into the drawing.

**DRAWING INFORMATION:** Winner selection will be conducted by random drawing on July 1, 2021; winner will be notified by phone, email, or mail. Winner need not be present to win. Winner is not obligated to accept the prize. If winner refuses to accept the prize, a new winner will be drawn at random. Odds of winning depend on

the number of entries received. Prize is non-transferable and no prize substitutions or exchanges will be allowed except at the sole discretion of the Credit Union. Prizewinner is responsible for any federal, state, and local tax liability.

**CONTEST PRIZE:** Winner will be selected from the entries submitted. The prizewinner will receive a Shark Rocket Lightweight Cordless Stick Vacuum; color and/or model may vary based on availability. Retail value of the prize is approximately \$250.00. Taxes, insurance, and all other expenses associated with acceptance and use of the prize not stated herein is the sole responsibility of the prizewinner. All prize details are at CEFCU's sole discretion.

**CONSENT AND RELEASE:** By entering the Promotion, each entrant releases and discharges CEFCU, and any other party associated with the development or administration of this Promotion, their parent, subsidiary, and affiliated entities, and each of their respective officers, directors, members, shareholders, employees, independent contractors, agents, representatives, transferees, and assigns (collectively, "Sponsor Entities") from any and all liability whatsoever in connection with this Promotion, including without limitation legal claims; costs; injuries; losses or damages; and demands or actions of any kind (including without limitation personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light) (collectively, "Claims").
