



## **Member Appreciation Day Cash Drawing Official Contest Rules**

**PROMOTION PERIOD:** Promotion begins on July 29, 2022 at 9:30am PDT and ends July 29, 2022 at 5:00pm PDT at our Milwaukie, Oregon branch. Promotion begins on August 5, 2022 at 9:00am PDT and ends August 5, 2022 at 5:00pm PDT at our Lewiston, Idaho branch.

**ELIGIBILITY:** No purchase is necessary to win. Cutting Edge Federal Credit Union (CEFCU, or henceforth the "Credit Union") Board of Directors, Supervisory Committee Members, and Employees and their immediate family members are not eligible to win. Prizewinners must be existing Credit Union members in good standing in order to be eligible to win.

**TO ENTER:** Existing CEFCU members who visit the branch during each respective Promotion Period will receive one (1) drawing entry ticket. Existing CEFCU members who visit the branch from 12:00pm-3:00pm during each respective Promotion Period will receive two (2) drawing entry tickets. Existing CEFCU members who bring an eligible referral who then opens membership at the Credit Union during each respective Promotion Period will receive three (3) drawing entry tickets; the referred new member will also receive three (3) drawing entry tickets.

To earn one (1) entry without purchase or obligation: print your name, address, city, state, zip code, and phone number on a 3"x5" card and the words "Cutting Edge Federal Credit Union 2022 Member Appreciation Day \$500 Cash Drawing Postcard Entry."

Entries must be received no later than July 29, 2022 to be entered into the Milwaukie, Oregon Member Appreciation Day drawing. Entries must be received no

later than August 5, 2022 to be entered into the Lewiston, Idaho Member Appreciation Day Drawing.

**DRAWING INFORMATION:** Winner selection will be conducted by random drawing at each Credit Union branch location at the conclusion of their respective Promotion Periods; winner will be notified by phone, email, or mail. Winner need not be present to win. Winner is not obligated to accept the prize. If winner refuses to accept the prize, a new winner will be drawn at random. Odds of winning depend on the number of entries received. Prize is non-transferable and no prize substitutions or exchanges will be allowed except at the sole discretion of the Credit Union. Prizewinner is responsible for any federal, state, and local tax liability.

**CONTEST PRIZE:** A prizewinner at each Credit Union branch location will be selected from the entries submitted at each CEFCU branch. The prizewinner at each branch location will receive five-hundred dollars (\$500.00) cash. Retail value of prize is \$500.00. Taxes, insurance, and all other expenses associated with acceptance and use of the prize not stated herein is the sole responsibility of the prizewinner. All prize details are at CEFCU's sole discretion.

**CONSENT AND RELEASE:** By entering the Promotion, each entrant releases and discharges CEFCU, and any other party associated with the development or administration of this Promotion, their parent, subsidiary, and affiliated entities, and each of their respective officers, directors, members, shareholders, employees, independent contractors, agents, representatives, transferees, and assigns (collectively, "Sponsor Entities") from any and all liability whatsoever in connection with this Promotion, including without limitation legal claims; costs; injuries; losses or damages; and demands or actions of any kind (including without limitation personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light) (collectively, "Claims"). Except where prohibited: (i) acceptance of a prize constitutes the consent of any winner, without further compensation, to use the name and likeness of such winner for editorial, advertising and publicity purposes by CEFCU; (ii) acceptance of a prize constitutes a release by any winner of the Sponsor Entities of any and all Claims in connection with the administration of this Promotion and the use, misuse, or possession of any prize; and (iii) potential winner may be required an affidavit of eligibility (including social security number) and a liability and/or publicity release.
