



## ***Monthly Drawing Official Contest Rules***

**PROMOTION PERIOD:** Promotion begins on October 1, 2023 at 12:00am PDT and ends September 30, 2024 at 5:00pm PDT.

**ELIGIBILITY:** No purchase is necessary to win. Cutting Edge Federal Credit Union (CEFCU, or henceforth the "Credit Union") Board of Directors, Supervisory Committee Members, and Employees and their immediate family members are not eligible to win.

**TO ENTER:** New members who open an account during the Promotion Period will be automatically entered. Current CEFCU members who refer a new member who opens an account at the Credit Union with a referral coupon or through the referral form on the Credit Union's website will be automatically entered to win. Members are also automatically entered by applying for and obtaining any CEFCU loan product, including a Visa® Credit Card and/or by refinancing a loan from another financial institution with CEFCU. To enter without purchase or obligation: print your name, address, city, state, zip code, and phone number on a 3"x5" card and the words "Cutting Edge Federal Credit Union Monthly Drawing Contest."

Entries must be postmarked no later than the 15<sup>th</sup> day of each month to be entered into the monthly drawing.

**DRAWING INFORMATION:** Winner selection will be conducted by random drawing at each Credit Union branch location on or around the 6<sup>th</sup> day of each month during Promotion Period; winner will be notified by phone, email, or mail. Winner need not be present to win. Winner is not obligated to accept the prize. If winner refuses to accept the prize, a new winner will be drawn at random. Odds of winning depend on the number of entries received. Prize is non-transferable and no prize substitutions

or exchanges will be allowed except at the sole discretion of the Credit Union. Prizewinner is responsible for any federal, state, and local tax liability.

**CONTEST PRIZE:** A winner at each Credit Union branch location will be selected from the entries submitted at each CEFCU branch. The prizewinner at each branch location will receive a twenty-five dollar (\$25.00) Visa® gift card. Retail value of gift card is \$25.00. Taxes, insurance, and all other expenses associated with acceptance and use of the prize not stated herein is the sole responsibility of the prizewinner. All prize details are at CEFCU's sole discretion. The credit union will also make a twenty-five dollar (\$25.00) donation to Credit Unions For Kids (CU4Kids), a (501)(c)(3) organization, on behalf of the prizewinner. Prizewinner will not be responsible for taxes, insurance, or any other expenses associated with the CU4Kids donation.

**CONSENT AND RELEASE:** By entering the Promotion, each entrant releases and discharges CEFCU, and any other party associated with the development or administration of this Promotion, their parent, subsidiary, and affiliated entities, and each of their respective officers, directors, members, shareholders, employees, independent contractors, agents, representatives, transferees, and assigns (collectively, "Sponsor Entities") from any and all liability whatsoever in connection with this Promotion, including without limitation legal claims; costs; injuries; losses or damages; and demands or actions of any kind (including without limitation personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light) (collectively, "Claims").
