



Car Detailing Kit Drawing Official Contest Rules

PROMOTION PERIOD: Promotion begins on February 1, 2024 at 12:00am PST and ends on April 30, 2024 at 5:00pm PDT. All Cutting Edge Federal Credit Union loan programs and promotions and conditions are subject to change at any time.

ELIGIBILITY: No purchase is necessary to win. Cutting Edge Federal Credit Union (CEFCU, or henceforth the "Credit Union") Board of Directors, Supervisory Committee Members, and Employees and their immediate family members are not eligible to win.

TO ENTER: Members who open an auto loan during the Promotion Period will be automatically entered.

To enter without purchase or obligation: print your name, address, city, state, zip code, and phone number on a 3"x5" card and the words "Cutting Edge Federal Credit Union 2024 Spring Auto Loan Car Detailing Kit Prize Drawing."

Entries must be postmarked no later than April 15, 2024 to be entered into the drawing in this manner.

DRAWING INFORMATION: Winner selection will be conducted by random drawing on or around May 1, 2024; winners will be notified by phone, email, or mail. Winners need not be present to win. Winner is not obligated to accept the prize. If winner refuses to accept the prize, a new winner will be drawn at random. Odds of winning depend on the number of entries received. Prize is non-transferable and no prize substitutions or exchanges will be allowed except at the sole discretion of the Credit Union. Prizewinner is responsible for any federal, state, and local tax liability.

CONTEST PRIZE: Two winners will be selected, one from each assigned branch community. The prizewinners will receive an Armor All Ultimate Car Detailing Kit and a gift certificate for a local interior detailing service for up to \$200. Retail value of

the prize is approximately \$250.00. Taxes, insurance, and all other expenses associated with acceptance and use of the prize not stated herein is the sole responsibility of each prizewinner. All prize details are at CEFCU's sole discretion.

CONSENT AND RELEASE: By entering the Promotion, each entrant releases and discharges CEFCU, and any other party associated with the development or administration of this Promotion, their parent, subsidiary, and affiliated entities, and each of their respective officers, directors, members, shareholders, employees, independent contractors, agents, representatives, transferees, and assigns (collectively, "Sponsor Entities") from any and all liability whatsoever in connection with this Promotion, including without limitation legal claims; costs; injuries; losses or damages; and demands or actions of any kind (including without limitation personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light) (collectively, "Claims").
